## COUNCIL ON EDUCATIONAL POLICY 2020-21 ANNUAL REPORT

## **COUNCIL OPERATIONS**

The Council on Educational Policy (CEP) is charged with considering all academic policy matters related to undergraduate education. The Council's duties are outlined in <u>Irvine Bylaw 85</u>. Professor Tony Smith, Social Sciences, chaired the Council in 2020-21. The Council met eight times during the academic year.

#### **REVIEW OF DIVISIONAL SENATE ISSUES**

#### **Review of the Multicultural Studies General Education Requirement** – 11/5/20

At the request of Senate leadership, CEP was asked to review the current learning outcomes associated with GE Area VII (Multicultural Studies) and propose updated catalogue copy for Cabinet discussion. Once the catalogue copy has been updated, SCOC will review all GE VII courses to ensure they are consistent with the new description.

#### **Review of the Online Undergraduate Degree Task Force Report** – 11/5/20

In response to a UCI proposal for a fully-online BA in Business Administration for transfer students, the Systemwide Academic Senate convened a Task Force in AY 2019-2020 to examine

the implications of possibly creating full-time online undergraduate degree programs at the University of California. After review, members felt that the report was well-researched, thorough, and helpful for thinking through various issues that would be presented should UCI choose to launch fully online undergraduate degrees in the future. CEP recommended that UCI faculty should have the option to choose to offer online undergraduate degrees in the future.

# Irvine Regulation A465: Final Examinations Requirements – 1/7/21

The existing final examination requirements as outlined in IR A465 were outdated and did not fit the needs of many classes on campus. Members noted that this regulation is separate from scheduling space for final exams for courses offered off the standard schedule and that the proposed revisions align with current campus practices. The Subcommittee on Policy and Assessment proposed revisions for CEP's consideration, which were subsequently approved.

# Independent Study Course Review – 2/4/21

Following review of independent study courses, a CEP subcommittee proposed revisions to the relevant sections of the Senate Manual. The proposed changes included making the assessment criteria for grades available to students in the form of written expectations, a syllabus, or other guiding document and capping the number of independent study units that may be taken for a letter grade at 30.

# **Grading Policy Discussion** – 3/4/21

CEP welcomed Professors Anita Casavantes Bradford and Pavan Kavandale to present their recommendations for potential long-term changes to undergraduate grading policies on campus. The professors provided a brief history on grading practices, explained how grading practices can be inaccurate and inequitable, and how these practices impact students. Chair Smith suggested CEP form a subcommittee to analyze and develop grading policy recommendations.

# **Grading Option Deadline** – 3/4/21

CEP endorsed a revision recommended by the Subcommittee on Policy and Assessment that the undergraduate grading option deadline be permanently changed to Friday of week 10 at 5pm, effective Spring 2021. Current limits on courses that cannot be taken Pass/Not Pass would remain unchanged.

# Extension of Waiver to Allow Departments to Offer Courses Online Without Prior Approval – 3/4/21

To minimize confusion about whether existing in-person courses need to be formally approved by the Academic Senate for online delivery, the Subcommittee on Courses & Continuing, Part-Time, & Summer Session Education (SCOC) and Council on Educational Policy (CEP) extended the following 2020-21 guidance through Winter Quarter 2022: Undergraduate programs do not need to seek formal approval for existing in-person courses to be offered in a remote or hybrid mode, as a temporary measure, due to COVID-19 restrictions for in-person courses. SCOC will continue to consider proposals for online courses intended to be offered on a long-term basis. Proposed courses that use online tools to enhance the learning experience beyond that of an in-person course are more likely to be viewed favorably.

# Pre-Proposal to establish a School of Population and Public Health - 5/6/21

At the request of Senate leadership, CEP reviewed the pre-proposal to establish a School of Population and Public Health. Members found several strengths and several concerns with the pre-proposal, which were submitted to Cabinet.

# **REVIEW OF SYSTEMWIDE ISSUES**

#### **Proposed Changes to Systemwide Senate Regulation 630** – 10/1/20

CEP discussed the revisions proposed by the University Committee on Educational Policy to Systemwide Senate Regulation 630, which outlines the senior residency requirement. The proposed changes seek to simplify the regulation and clarify questions while recognizing that students should satisfy the majority of their upper division requirements via courses offered by their home campus. Members were supportive of the proposed changes and agreed that the revisions will eliminate ambiguity.

#### Systemwide Review of the Innovative Learning Technology Initiative – 1/7/21

CEP reviewed and recommended that ILTI be refocused to serve as a central coordinator of online course development efforts at the campuses, distribute block grants, and work to negotiate software contracts and vet educational software systems on behalf of the campuses.

#### Proposed Changes to Systemwide Senate Regulation 610 - 4/1/21

CEP reaffirmed that residency is validated by enrolling in Senate-approved courses and is not limited to in-person courses.

#### Systemwide Review of COVID-19 Vaccination Program – 5/6/21

CEP discussed the proposed new SARS-CoV-2 (COVID-19) Vaccination Program and did not wish to opine.
