

Irvine Division of the Academic Senate Annual Report 2019-2020

Submitted to the Divisional Senate Assembly August 31, 2020

Chair's Summary

As you might imagine, the 2019-20 academic year turned out to be a busy one for the Irvine Division of the Academic Senate. Our various councils and committees convened some 185 times for regularly scheduled meetings, yet this number barely captures the participation of Senate members in ad hoc deliberations, information sessions, special meetings, and administrative crisis-management groups as the COVID-19 pandemic unfolded. Let me begin, however, with a few important items of what we might retrospectively label "business as usual." During the course of the year, the Senate reviewed and approved the establishment of a new School of Pharmacy and Pharmaceutical Sciences, reviewed and approved a Doctor of Pharmacy program for said school, as well as vetted and endorsed departmental transfers, consolidations, and establishments in the Program in Public Health. These were all important steps in the creation of the Susan and Henry Samueli College of Health Sciences. We considered and commented on thirteen systemwide reviews, including proposed revisions to the Presidential Policy on Copyright Ownership, the report of the Standardized Testing Task Force, and proposed revisions to the Presidential Policy on the Protection of Human Subjects in Research. We reviewed and endorsed six new endowed chairs, and we did much else besides.

The Fall Quarter saw the start of a newly configured Academic Planning Group (APG), a joint Senate-Administration committee that is advisory to the Provost and Executive Vice Chancellor. Considerably smaller than the previous incarnation of the APG and more focused on establishing and coordinating high-level task groups, the general sense of those involved in the change was that the new APG was mainly a success but that the group needed to be expanded somewhat to ensure a diversity of views and voices. This expansion and diversification has been implemented for 2020-21. The past year's chief APG topics and the foci of individual task groups were data use and privacy, self-supporting graduate professional degree programs, and the relative advantages and disadvantages of guarter versus semester systems. As a result of the work of APG core members and task groups, the Provost has been provided with numerous recommendations and extensive reports: ideas for better monitoring who has access to data generated on campus and how such data gets used; analyses that provide a better understanding of self-supporting program finances and how to maintain the fiscal firewall between self-supporting and state-supported programs. The quarters-versus-semesters task group, amid the pandemic upheaval, decided that the moment was inopportune to contemplate a significant scheduling change. The preliminary work of the group has been archived, however, for future reference.

During the winter quarter, key councils of our divisional Academic Senate began their reviews of various proposals related to the establishment and configuration of the College of Health Sciences. There was considerable back-and-forth between the Senate and proposers, and it was my sense that all parties felt that the proposals had been improved in the process. In late February, the Senate held its annual awards event to honor eight outstanding colleagues for their contributions to research, service, teaching, and mentorship. This was our second year holding the event in the Newkirk Alumni Center and of generally aiming to elevate the profile

and presentation of the awards ceremony. Feedback and attendance suggest that we are very much on the right track. Of course, only a few weeks later, an in-person event of the sort became unthinkable—temporarily, we trust. The Senate turned rapidly to negotiating the abrupt switch to remote learning, suspended research, and multiple other ramifications of the COVID-19 pandemic.

By the beginning of the Spring Quarter, most all of us were working from home, with exceptions for the "essential," including researchers whose work bears directly on the public health crisis. In the Senate, we continued with our regular schedule of council and committee meetings, as we learned to vote by "little blue hand" and otherwise adapt to our new virtual reality. During this guarter and in relation to COVID-19, the Senate promulgated exceptional policies on pass/not pass grading options for undergraduates, made procedurally important distinctions between remote and online courses, and addressed a number of issues related to graduate education, including admissions and grading flexibility. Senate faculty representatives as well as Senate staff were also actively engaged in the work of numerous administrative committees and response teams. Because these committees and teams are not Senate bodies, they don't show up in our accounting below, but you should know that we had and continue to have a strong voice on groups such as the Provost's COVID-19 Strategic Advisory Group, the COVID-19 Budget Work Group, the Campus Recovery Implementation Team, task forces dedicated to educational continuity for undergraduates and for graduate students, to restarting research, as well as to symptom checking, contact tracing, travel risk review, and more. As chair of the Academic Senate during this tumultuous time, let me take this opportunity to express my appreciation of the Administration's willingness-indeed, eagerness-to involve the Senate across the board as part of the campus's crisis response. For me, the culmination of this collaboration was the virtual town hall that the Academic Senate hosted and at which the Chancellor, Interim Provost, Vice Chancellor for Research, Vice Provost for Graduate Education, and Vice Provost for Teaching and Learning took questions from faculty, addressed our concerns, and took onboard our advice about a phased return to the campus.

Let me conclude with a few observations about the Senate's current and future role in what we might call the standing crisis of our nation: the various and unevenly distributed failures of representation, inclusion, community, and safety. 2019-20 saw the first full year of operations of the Academic Senate's new Council on Equity and Inclusion (CEI). While it's clearly important for the Senate to have a committee of this sort, it was also important to hear the chair of CEI remind Senate leadership and other Cabinet members that the work of supporting equity and inclusion falls to all of us and cuts across all of our committees. Along these lines, the Academic Senate has committed its full and broad support to the Vice Chancellor for Equity, Diversity, and Inclusion's recently launched Black Thriving Initiative. We have strengthened ties between the Senate and the Public Safety Advisory Committee, adding a dedicated Senate representative to the group to ensure communication and coordination as we work to change the culture and nature of policing on campus and in the community. We have been and will continue to work with the Office of Academic Personnel to address career impacts of the COVID-19 disruption over both the short and long runs, with particular attention to the unequal distribution of these impacts. Within the Senate, we have instituted a number of procedural changes intended to diversify membership on our councils and committees and to ensure that our representative bodies are truly representative.

It has been a pleasure and honor to serve as Senate Chair during this unusual academic year. My thanks go out to the Academic Senate staff, to all the chairs and members of councils, committees, boards, subcommittees, Cabinet, and Assembly, and to all of my Senate colleagues whose hard work and dedication under difficult circumstances have helped to prove the good of shared governance.
