# COUNCIL ON EDUCATIONAL POLICY 2019-20 ANNUAL REPORT

## **COUNCIL OPERATIONS**

The Council on Educational Policy (CEP) is charged with considering all academic policy matters related to undergraduate education. The Council's duties are outlined in <a href="Irvine Bylaw 85">Irvine Bylaw 85</a>. Professor Tony Smith, Social Sciences, chaired the Council in 2019-20. The Council met eight times during the academic year.

## **REVIEW OF DIVISIONAL SENATE ISSUES**

## Recording of Lectures by Students – 11/7/19, 12/5/19

At the request of Senate leadership, CEP discussed whether students should be required to seek permission from an instructor before recording a lecture. CEP concluded that unless an instructor informs students in class and on the course syllabus that recording lectures or classes is prohibited, students should assume they are permitted to do so. CEP strongly agreed that students cannot post faculty lectures and classes online in any form without the explicit written consent of the instructor. Any recording of a faculty lecture or class must not expose or identify other students in the class in conformity with the Family Educational Rights and Privacy Act (FERPA). CEP expressed that faculty should also seek permission from students before recording them during class.

# **Residency Requirement** – 11/7/19, 12/5/19

At the request of Senate leadership, CEP discussed the undergraduate residency requirement. Irvine Regulation 515 currently states "At least 36 of the final 45 units completed by each candidate for the Bachelor's degree must be earned in residence at Irvine." CEP determined that the systemwide definition of "residence" provided in SR 610 does not require students to take classes on campus, and instead indicates "a program of courses approved by the Faculty of a student's college or school."

## **Making Council Agendas/Minutes Public** – 12/5/19

Senate Chair Steintrager asked Councils to consider whether they supported posting meeting agendas and minutes publicly on the Senate website. CEP members were in favor of keeping agendas and minutes accessible to members only.

## Student Course Feedback Form – 2/6/20, 3/5/20

At the request of Senate leadership, CEP provided feedback on a new student course feedback form proposed by the Council on Teaching, Learning, and Student Experience. CEP was unanimously and strongly opposed to the new form, and expressed a desire for the Senate to explore other instruments to determine student mastery of course material.

# Proposal for a New School of Pharmacy and Pharmaceutical Sciences – 2/6/20 CEP endorsed the proposal.

## Quarters vs. Semesters – 2/6/20

CEP discussed the pros and cons of the quarter and semester systems in order to provide feedback to the Academic Planning Group (APG) task group on this topic. APG submitted a report to the Provost for consideration, but there are no plans to proceed with a change at this time.

English Proficiency Certification for Teaching Assistants and Teaching Associates – 2/6/20 CEP endorsed a revision to the English proficiency policy for Teaching Assistants and Teaching Associates. This policy will be implemented in fall 2020.

## Independent Study Courses – 3/5/20, 4/2/20

At the request of Senate leadership, CEP discussed whether requirements for syllabi for independent study courses should be strengthened. CEP reaffirmed the existing policy, which states that "The individual program of study for these courses, as proposed by a student or faculty member for a specific quarter, must be submitted in writing and approved by the chair of the

department or program prior to being offered." Several members of CEP were not familiar with this policy prior to discussion, and indicated that this policy is not well known or followed across campus. CEP plans to reach out to Associate Deans and Department Chairs to collect more information before revisiting this topic in Fall 2020.

# Employing Self-Supporting Graduate Professional Degree Program Students as Teaching Assistants -4/2/20

At the request of Senate leadership, CEP discussed a recommendation from the Graduate Council that students enrolled in Self-Supporting Graduate Professional Degree Programs (SSGPDPs) be permitted to serve as Teaching Assistants. CEP supported the following statement: "Given the current practice, SSGPDP students should only be considered in the event that 1) a qualified PhD student, not necessarily in the same school or discipline; or 2) a qualified state-supported master's student not necessarily in the same school or discipline was not identified."

# **Actions from the Program in Public Health** – 4/2/20

At the request of Senate leadership, CEP reviewed several actions from the Program in Public Health. These included a transfer and name change of the Department of Epidemiology; creation of two new departments, Department of Environmental and Occupational Health and Department of Health, Society and Behavior; and information on the state of the Department of Population Health and Disease Prevention as a result of these actions. CEP approved these actions and asked for assurance that there would be sufficient faculty to meet teaching obligations in the reconfigured Program in Public Health. CEP also inquired if the new Departments had any plans to offer undergraduate degree programs.

## Writing 39B Test-Out Pilot – 5/7/20

CEP voted in favor of a proposal from the School of Humanities to make the Writing 39B test-out pilot permanent.

# Demonstration Project to Offer UCI Courses and B.A. in Sociology to Students Living in Prison -6/4/20

CEP enthusiastically endorsed a proposal from Professors Keramet Reiter, Val Jenness, and Carroll Seron to launch a collaborative demonstration project between Southwestern College, Ronald J. Donovan Correctional Facility (RJD), and UCI to offer a B.A. in Sociology to students living at RJD. Faculty in the Department of Sociology voted strongly in favor of this proposal based on a memorandum of understanding between the department and the Dean of Social Sciences. This will be only the second B.A. program for students who are incarcerated in California, and the first offered by a UC campus.

## Standardized Testing Task Force Report – 3/5/20

CEP discussed the Standardized Testing Task Force Report. Most members felt that replacing the SAT and ACT with another standardized test was not feasible, but were split on the report's other recommendations.

## Elimination of SAT Writing Requirement – 3/5/20

CEP discussed the Board of Admissions and Relations with Schools recommendation to eliminate the SAT writing requirement for applicants. CEP agreed with this recommendation.

Proposed Presidential Policy on Gender Recognition and Lived Name -4/2/20 CEP discussed the proposed new Presidential Policy on Gender Recognition and Lived Name and had no concerns.
