

**COMMITTEE ON RULES AND JURISDICTION
ANNUAL REPORT
2019 – 2020**

The Committee on Rules and Jurisdiction, as charged in Irvine Bylaw 125, reviewed legislation to be presented for action to the Divisional Senate Assembly to verify conformity with the format and content of the Code of the Academic Senate and advised the Division, its Officers, Committees, Faculties, and members in matters of organization, jurisdiction, and interpretation of legislation of the Academic Senate and its agencies. The committee conducted its reviews electronically.

I. Irvine Bylaws

- a. Bylaw 90. Equity and Inclusion, Council on (11/15/19) (1/21/20)
The modifications updated the title of one of the ex officio members, whose position had been elevated to Vice Chancellor, and replaced a current ex officio member, the Vice Provost for Academic Planning, with the Vice Provost of Academic Personnel.
- b. Bylaw 127. Scholarly Honors and Awards, Committee on (1/21/20) (1/30/20)
The modifications gave SHA, in consultation with the Senate Chair, the ability to modify award names and add new awards without needing to update its bylaws each time.
- c. Bylaw 138. Teaching, Learning, and Student Experience, Council on (4/21/20) (5/7/20)
The modifications increased membership on the Board of Undergraduate Scholarships, Honors and Financial Aid (BUSHFA) from 10 to 12 and changed ex-officio members from the Vice Chancellor of Student Affairs and Vice Provost of Teaching and Learning to a representative from those offices.

II. Irvine Regulations

- a. Regulation 635. The School of Social Ecology
This revision addressed the name change of the B.A. in Psychology & Social Behavior to the B.A. in Psychological Science.

III. Irvine Senate Manual Appendices

- a. Appendix I: Chapter V. The Henry Samueli School of Engineering (6/16/20)
The modifications clarify the voting membership of standing committees within the Executive Committee of The Henry Samueli School of Engineering.
